What rights arise?

- inventions & hence patents

- copyrights & how to protect and enforce them
- database rights & how to protect and enforce them

Patents

- basic facts on patentability (novelty, inventive step etc; exclusions e.g. surgical methods)
- basics of the application procedure (national / EPO / PCT)
- how they are used (licensing-in and -out; sale etc). Include "Research Exemption" & compulsory licensing.
- patent information as source of technical information & commercial intelligence

Ownership & collaboration

- the hazards of "co-invention" (e.g. McGriskin versus Webb)
- Lambert Model Agreements

Patentability

Which criteria and aspects apply when assessing the Novelty or the Inventiveness of an invention (absolute concept of Novelty; 'problem-solution approach')

Loss of rights

Pitfalls to avoid and obey as Inventor/Applicant - e.g., oral disclosure at consortiums, conferences, abstracts or presentations at seminars

The presentation will cover the following questions:

- What are possible "legitimate interests of other ExtreMat partners"?
- Do I have to inform all other ExtreMat project partners and the CEC before filing a patent application?
- How do I have to do this? How long in advance?
- What information do I have to unveil in this announcement? How does this interfere with confidentiality and protection?
- Do I have to file patent applications jointly, if there were other partners involved in the research? Or can I file it alone in a first step and then include further partners later?
- Can other partners object my announcement of filing of a patent? For what reasons? What happens then?





- Can they still object after my patent application is filed?
- May other ExtreMat partners express interest in using my results in other geographical areas or application fields, where I don't intent to use them?
- Am I obliged to file a European or PCT application if I only want to use the result locally?
- Am I obliged to protect applications only other ExtreMat project partners are interested in, but I am not?
- Who pays the additional costs, then? What will be the terms of use?
- How can I proceed if we do not agree on a joint strategy? Do I have to delay patent application before this disagreement is settled?
- Do I have to mention the FP6-funded project ExtreMat in the patent application?
- If I generated an exploitable result in ExtreMat and want to commercialise it externally, e.g. by selling or licensing it to someone outside the ExtreMat consortium:
- Do I have to inform the ExtreMat partners and the CEC in advance on my plans?
- Do I need their approval? May they object to this licensing? What are the rules for this case? What are the deadlines for objection?
- What are the terms of use I have to offer to them? What are "fair conditions"?
